"Strategic sale means that you are looking for a strategic partner, not selling to

#### DoD wants subsidy roadmap before **ONGC** disinvestment

The Department of Disinvestment (DoD) wants the Government to lay out a roadmap for fuel subsidy sharing before the Rs 14,000 crore stake sale in Oil and Natural Gas Corp (ONGC), a top official said. The government had in 2014 planned to sell its 5 per cent stake in the staterun explorer but met with lukewarm response retail investor," Finance Secretary Rajiv Mehrishi told reporters here. Asked if strategic will only mean below 51 per cent, Mehrishi said: "Not necessary". For the full fiscal 2015-16, the government hopes to garner Rs 69,500 crore through stake sale in PSUs. Of this, Rs 41,000 crore is estimated to come from minority stake sale in PSUs and the remaining Rs 28,500 crore from strategic stake sale. Mehrishi said the Finance Ministry would "go ahead" with the stake sales depending on need as well as the appetite in stock markets.

Last month, the finance ministry wrote to state-run bank chiefs, asking them to tap into their corporate social responsibility (CSR) fund so that they could contribute to the Swachh Bharat Kosh, being managed by the expenditure department. Of course, the letter was not a diktat from the

#### Budget 2015: Government allocates \$388 million to fill oil storage

The government has provided 24 billion rupees in the revised budget estimates for the current fiscal year to fill its first strategic crude reserves, a statement said on Monday, indicating oil could be purchased by end-March. A fall in oil prices helped Finance Minister Arun Jaitley to present a budget that loosened the reins on public spending to drive growth as the federal government could save billions of dollars in oil subsidy. India, the world's No.4 crude consumer, is building storage facilities at three locations in the south of the country to hold a total 36.87 million barrels of oil, enough to cover about 13 days of its needs in case of a supply disruption. The first underground facility at Vizag that can hold 9.75 million barrels is completed and ready for commissioning.

#### Jan infra output growth at more than a year's low of 1.8 pct

India's annual infrastructure output growth slowed to more than a year's low of 1.8 percent in January, mainly dragged down by a sharp slowdown in crude oil and natural gas production, government data showed on Monday. The output had expanded 2.4 percent year-on-year in December. The infrastructure sector, which comprises coal, crude oil, oil refining, natural gas, steel, cement, electricity and fertilisers, accounts for 37.9 percent of India's industrial output.

## Govt wants Sebi, not RBI, to regulate money market

The government has proposed to amend the Reserve Bank of India (RBI) Act to take away money market regulatory powers from the central bank and bring it under the purview of the Securities and Exchange Board of India (Sebi). Though the proposal wasn't mentioned in Finance Minister Arun Jaitley's Budget speech, the Finance Bill proposes to amend sections 45U and 45W of the RBI Act, which effectively takes away the central bank's powers to regulate government securities and other money market instruments. The amendment to section 45W says, "Any direction issued by the Reserve Bank of India, in respect of security, under chapter III D of the Reserve Bank of India Act, shall stand repealed." Usha Thorat, former deputy governor of RBI, said, "Certain powers in relation to regulating money market instruments and products and derivatives based on these instruments were given to RBI in 2005-06 by amending the RBI Act and this

### RBI cuts repo rate by 25 bps ahead of policy schedule once again

Raghuram Rajan, governor, Reserve Bank of India (RBI), seems to enjoying surprising the markets by cutting rates unannounced and ahead of monetary policy reviews. After the rate cut on January 15, the Bank has cut rates by 25 basis points on Wednesday morning bringing the key repo rate down to 7.50%. Rajan said, "Given low capacity utilisation and still-weak indicators of production and credit off-take, it is appropriate for the Reserve Bank to be pre-emptive in its policy action to utilise available space for monetary accommodation. He gave two factors to defend his second surprise rate cut before the monetary policy. First, the still weak state of certain sectors of the economy as well as the global trend towards easing suggests that any policy action should be anticipatory once sufficient data support the policy stance.

#### **DGCA** sets up unit to monitor airfares

Regulator Directorate General of Civil Aviation (DGCA) has set up a tariff monitoring unit to check on air fares on certain routes selected randomly to ensure that airlines stay within the price range set by them. An analysis has shown that fares remain well within the range displayed by the airlines on their websites, minister of state for civil aviation Mahesh Sharma said in a written reply in the Rajya Sabha on Tuesday. The minister clarified that air fares are not regulated by the government. "Under the provision of Sub Rule (1) of Rule 135, Aircraft Rules 1937, airlines are free to fix reasonable tariff having regard to all relevant factors, including the cost of operation, characteristics of services, reasonable profit and the generally prevailing tariff," he said.

#### Narendra Modi's \$1 trillion plan revives tax-free rail debt

India's decision to allow tax-free bonds after a 12-month hiatus should cut borrowing costs for \$1 trillion development push. Finance minister Arun Jaitley said in his budget speech last month that tax-free bond sales to individuals for rail, road and irrigation projects will be permitted from 1 April. While issuance wasn't banned as such this fiscal year, offerings halted because no quotas were allocated. India plans to spend about Rs.8.5 trillion upgrading its antiquated rail network over the next five years, budget documents released in New Delhi show, as it seeks to support economic expansion as fast as 8.5% next year. A second international airport for Mumbai is in the works, as is a dedicated rail transport corridor for freight between Delhi and Mumbai, the nation's two largest cities. "Taxfree bonds will reduce the cost of borrowing for issuers and will have a multiplier effect on job creation," Indian railway finance managing director Rajiv Datt said.

While business visitors come round the year, we receive leisure tourists during winter and June-August. The Emiratis mostly visit Mumbai, Kerala and Goa. They are high spenders and the average length of stay is a week or longer. While we don't see a significant impact immediately, there could be cancellations if the swine flu outbreak is not brought under control."

#### Major ports and highways to contribute 2 per cent of GDP: Nitin Gadkari

Road Transport, Highways and Shipping Minister Nitin Gadkari today said efforts are on to develop all 12 major ports so that they, along with the highways sector, contribute 2 per cent of India's GDP. Addressing media after a MoU for export of cars was signed between Kamarajar Port and Toyota, Gadkari said the company is exploring more countries, apart from South Africa, for exporting its vehicles. #### A new service helps ships change routes, conserve fuel

## India ranks third lowest in having women in leadership roles

India ranks third lowest in the proportion of business leadership roles held by women, at 15 per cent; falling below the global average, reveals an annual survey from Grant Thornton, conducted ahead of International Women's Day (March 8). Japan which sits at the bottom of the global rankings at 8 per cent and Germany at 14 per cent, join India at the bottom of the rankings. Globally, 22 per cent of senior roles are held by women, a slight improvement up from 19 per cent in 2004 but, down from 24 per cent last year, highlighting broad stagnation. And almost a third of businesses have no women in senior leadership roles. "Japan and India may be at very different stages of their development but they share certain cultural features, such as strong hierarchy and patriarchal societies, which prevent women from reaching the upper echelons of the business world," said Pallavi Bakhru, Director, Grant Thornton Advisory Private Ltd.
